## Wedding Sales Contract

- 1) **SELLER** Flowers By Victoria, upon acceptance of this contract, agrees to provide all flowers, accessories, and rental items as specified in our sales quote form. Flowers By Victoria will also deliver & set-up any and all items as noted in said sales quote form to any and all locations specified.
- 2) **PURCHASER** The above named purchaser(s) do hereby agree to purchase any and all flowers, accessories, and other items as specified on sales quote form at prices listed. Purchaser(s) further agree to all payment, delivery, and terms and conditions below.
- 3) **ITEM CHANGES** Both the seller and the purchaser(s) do hereby agree that any and all changes to the items on the sales quote form must be agreed to by both parties. Any and all changes must be made no later than 15 days prior to event date above and all changes are subject to approval.
- 4) **PAYMENT TERMS** Upon accepting this agreement a \$150 initial deposit to hold the event date above is due payable to Flowers By Victoria. Acceptable forms of payments are cash, personal check, Visa, or MasterCard. An invoice will be mailed approximately 30 days before the above event date and any and all remaining balance on said invoice will be due 15 days prior to the event. Acceptable forms of payments for the remaining balance due are cash, personal check, Visa, or MasterCard. In most instances half (50%) of the initial deposit is refundable up to 120 days prior to the event date above. Any cancellations with less than 120 days notice will result in loss of full deposit amount. Failure to pay the total balance due by due date will result in this contract being considered canceled and null and void.
- 5) **DELIVERY & SET-UP** Flowers By Victoria will deliver and set-up any and all items as stated on the sales quote form. Purchaser(s) are responsible to insure that any and all delivery locations will be open and a purchasing party representative will be available to accept deliveries at times specified. In the event that delivery of any or all items can not be made at the scheduled time, an attempt will be made to contact the purchaser(s) at above phone numbers. Any changes to delivery locations or times must be made no later than 48 hours before the delivery date and may be subject to additional delivery costs.
- 6) **COLOR AND FLOWER VARIATIONS** Due to natural occurring variations in flowers, Flowers By Victoria can not guarantee that all flowers in all arrangements will be the exact same shade or size. Any variations in color are usually very minor and small.
- 7) **FLOWER SUBSTITUTIONS** In order to provide you with the freshest flowers, Flowers By Victoria uses many different growers from around the world. In very rare instances, due to weather conditions or shipping conditions some flowers may not be of the quality that we want to provide you with. In any instance where we can not get a flower or flowers that we agreed to provide you on our sales quote form, we will provide a like flower of equal or greater value. **(Flower Substitutions will only be made after every reasonable attempt has been made to provide you with your selected flower or flowers. In the event that a substitution is needed it will only be made after contacting the purchaser(s) and an agreement is verbally made between Flowers By Victoria and the purchasers to substitute said flower or flowers.)**
- 8) **LIABILITY** Flowers By Victoria is not liable if it fails to complete performance of its obligations because of fire or other casualty, illness, strikes, accidents, acts of God, or any other occurrences beyond its control. In said event Flowers By Victoria will immediately refund any and all costs in the form of a check and the above contract shall be considered terminated and null and void. Flowers By Victoria's full and complete liability, for any reason whatsoever, shall be limited to the full refund of all monies paid for flowers, accessories, rental items, delivery charges, and sales taxes.
